- ii. The student shall not change the approved course of study nor register himself/herself in any other course, program, university, or institution.
- iii. The student shall complete the prescribed academic program within the approved duration. In case of any extension beyond the prescribed period, the scholarship shall not be extended and shall automatically cease upon expiry of the approved duration.
- iv. In the event the student fails to qualify or complete the degree/program for which the scholarship has been awarded, the University reserves the right to recover all payments made and/or impose a penalty equivalent to the total scholarship amount from the student and/or Parent/Guardian.

**The scholarship shall be liable to termination in the following cases:**

- a) If the student fails to comply with the terms and conditions mentioned in the **Scholarship Award Letter**.
- b) If the student fails to maintain a minimum class attendance of **75%**.
- c) If the student fails to maintain a minimum **GPA of 2.5 in each semester**, or as prescribed by the University from time \_\_\_\_\_ to \_\_\_\_\_.
- d) If the student is found involved in malicious, illegal, or undesirable activities.
- e) If the student fails to comply with or act in accordance with any lawful order issued by the University.
- f) If the student is punished for violation of university rules, damage to university property, misconduct with staff or fellow students, \_\_\_\_\_ or \_\_\_\_\_ any disciplinary offense.
- g) If any information provided by the student is found to be false, misleading, or incorrect at any stage during the study \_\_\_\_\_ period.
- h) If the student fails to maintain the academic standards prescribed by the University.
